Sub: Effective Date-1 of the Scheme and fixing of the Record Date-1

Kindly refer to the following letters:

- Our letter dated 11<sup>th</sup> August, 2016 intimating you of the approval of the Scheme by the Board of Directors the Company;
- Our letter dated 1<sup>st</sup> June, 2017 intimating you of the sanction of the Scheme vide the Order dated 1<sup>st</sup> June 2017 passed by the Hon'ble National Company Law Tribunal, Bench at Ahmedabad ("the Order");
- ➤ Our letter dated 2<sup>nd</sup> June, 2017 wherein the Company has submitted the desired information pursuant to your "Observation Letter" dated 16<sup>th</sup> November, 2016 and in terms of the SEBI Circular No. CIR/CFD/CMD/16/2015 dated 30<sup>th</sup> day of November 2015;
- Part B Approval Letter dated 20<sup>th</sup> June, 2017 received from Bombay Stock Exchange.

The Merger Committee of the Board of Directors of the Company and the respective Committees of the Boards of ABNL and ABFSL, at their respective meetings held today, have, after considering the status of the conditions to the effectiveness of the Part II of the Scheme as set out in the Scheme, approved filing of the certified copy of the Order with the Registrar of Companies, Madhya Pradesh on Saturday, 1<sup>st</sup> July 2017 on which date the Company will be deemed to have complied with the provisions of Clause 26.1 and 26.3 of the Scheme. 1<sup>st</sup> July 2017 will be the Effective Date-1 and the Appointed Date for the effectiveness of merger of ABNL with Grasim. Upon the Part II of the Scheme becoming effective, ABNL shall stand transferred to and vested in Grasim with effect from the Effective Date-1 i.e. 1<sup>st</sup> July, 2017, as a going concern, in the manner more particularly provided in the Scheme.

The Committee also fixed Thursday, the 6<sup>th</sup> July 2017 as the "Record Date-1" for merger of ABNL with Grasim in terms of the Scheme for determining the entitlement of the equity shareholders of ABNL to receive fully paid up equity shares of the Company in the ratio of 15 (Fifteen) fully paid up equity share of ₹ 2/- (Rupees Two) each of the Company credited as fully paid up for every 10 (Ten) fully paid up equity shares of ₹ 10/- (Rupees Ten) each, held by such shareholder in ABNL.

- a) as Beneficial Owners at the close of working hours on 6<sup>th</sup> July, 2017, as per the list to be furnished by the Depositories (NSDL & CDSL) in respect of the equity shares of ABNL held in electronic form; and
- b) as Shareholders in the Register of Members of ABNL, after giving effect to all valid share transfers in physical form which are received on or before 6<sup>th</sup> July, 2017 by M/s. Karvy Computershare Private Limited, Hyderabad, the Share Transfer Agents and Registrars of the Company.
